- Site Plans:
  - 250 Quincy Private Road Application
    - Seeking to construct a private road and establish related Lots

DJ Vander Slik, from Quincy St Ventures, Jon Male from Exxel Engineering, and Attorney Eric Starck presented application. Male confirmed they continue to pursue and will submit the required materials pursuant to Section 3.29.

Vander Slik stated they were seeking a land division that needed street approval not a Site Plan. Starck continued to say a Private Road and a Site Plan were quite different from a legal standpoint. Ransford stated it was a disagreement in the interpretation of the ordinance. The township attorney, Mark Nettleton was not available for tonight's meeting, but Ransford is understands Nettleton agrees with the Planning Commissions interpretation: We are seeking to approve a Site Plan, which requires constructing a pathway along Quincy Street or payment in lieu of constructing a pathway.

Vander Slik thinks Quincy is too busy and the pathway will not be beneficial to the new homes. He agrees with everything except the pathway payment in lieu and would like attorney Starck and Nettleton to discuss at further length. If an exception is not given, then he will decide what his next step is.

## PLANNING COMMISSION COMMENTS:

It is the Planning Commission's job to uphold the ordinance and they do not feel there is room for an exception. Commissioner Pater made a motion to approve the Site Plan with the condition that the plan meets the content of the letter written on 5/7/20 by Vriesman & Korhorn, including payment in lieu of constructing a pathway; and meets the content of the memorandum provided by Fresh Coast Planning. Commissioner Dykstra seconded the motion. Motion approved unanimously.
