  - o Located on the north side of Byron Road, between 16<sup>th</sup> Avenue and 24<sup>th</sup> Avenue
- Vessel Athletic Special Use application
  - o Proposed athletic training facility located at 2593 Kenowa Avenue
- Jamestown One Planned Development
  - o Final Plan serving 21 duplex residential units
  - o Located on the east side of 32<sup>nd</sup> Avenue, between Greenly Street and Riley Street
