**NOTICE OF IN-PERSON PUBLIC MEETING OF THE
JAMESTOWN CHARTER TOWNSHIP BOARD OF TRUSTEES
WITH ALTERNATIVE ARRANGEMENTS FOR CONDUCTING MEETING INCLUDING VIA ELECTRONIC MEANS IF NECESSARY**

PLEASE TAKE NOTICE that on Monday, April 19, 2021, at 7:00 p.m., local time, a public hearing will be held by the Board of Trustees of the Charter Township of Jamestown, Ottawa County, Michigan, at the Jamestown Charter Township Hall, 2380 Riley Street, Hudsonville, Michigan, 49426, to hear and consider the following Mineral and Soil Removal application.

Section 1

The proposed Mineral and Soil Removal application proposes to excavate approximately 2.5 million cubic yards of sand resulting in a lake of approximately 11.3 acres. The application further proposes an end use of approximately 18 lots on a private road. The property is located on the south side of Riley Street, west of 16th Avenue at approximately 1850 Riley Street, parcel number 70-18-15-200-016. The legal description is as follows:

Section 2

Consistent with recommended guidance from the U.S. Centers for Disease Control and Prevention (CDC) and various orders issued by the Michigan Department of Health and Human Services, and in an effort to reduce the likelihood of spreading the Coronavirus (Covid-19), Jamestown Charter Township (the "Township") has instituted social distancing for attendees and participants for all meetings at the Township Hall, including the April 19, 2021 Board of Trustees meeting. All participants in and attendees at the Board of Trustees meeting are required to wear a mask.

To comply with recommendations for social distancing, public seating in the meeting room has been spaced to provide approximately six feet of distance between seats in the meeting room and, therefore, seating within the meeting room is limited to 16 persons. Attendees at the meeting are requested to observe social distancing of approximately six feet from other attendees.

FURTHER PUBLIC NOTICE is provided that, in the event that the number of persons in attendance is anticipated to exceed the maximum number of persons that can maintain adequate social distancing in the Township Hall or the Michigan Department of Health and Human Services issues a new order, the Board of Trustees will provide written notice at the Township Hall and on the Township's website, not less than 18 hours prior to the April

19, 2021 Board of Trustees meeting, that the Board of Trustees will conduct the April 19, 2021 Board of Trustees meeting via electronic means using ZOOM on-line video conferencing.

In all other respects, the April 19, 2021 Board of Trustees meeting will be held in accordance with Michigan's Open Meetings Act and the Board of Trustees' rules of procedure, as those rules may be modified from time to time.
