**ORDINANCE NO. 18-007**

**AN ORDINANCE TO AMEND THE ZONING ORDINANCE  
OF THE CHARTER TOWNSHIP OF JAMESTOWN**

**[Complete Prohibition of Marihuana Facilities/Establishments]**

THE CHARTER TOWNSHIP OF JAMESTOWN ORDAINS:

Section 1. **Prohibition of Marihuana Facilities/Establishments.** Chapter 3 of the Zoning Ordinance of the Charter Township of Jamestown is hereby amended by the addition of Section 3.36 thereto, which shall read in its entirety as follows:

**SECTION 3.36 MARIHUANA FACILITIES AND ESTABLISHMENTS  
PROHIBITED**

- A. The following uses are completely prohibited in the Township, and may not be established or operated in any zoning district, by any means, including by way of a variance:
- (1) Any and all types of a “marihuana establishment,” as that term is defined and used in Michigan Initiated Law 1 of 2018, commonly known as the Michigan Regulation and Taxation of Marihuana Act.
  - (2) Any and all types of a “marihuana facility,” as that term is defined and used in the Medical Marihuana Facilities Licensing Act, MCL 333.27101, *et seq.*
- B. This Section 3.36 does not limit any privileges, rights, immunities or defenses of a person as provided in the Michigan Medical Marihuana

Act, Michigan Initiated Law 1 of 2008, MCL 333.26421, *et seq.*, or as reflected in Section 3.4.I of this Ordinance.


Section 2.     **Publication and Effective Date.** A summary of this Ordinance shall be published in a newspaper of general circulation within the Township, as provided by law. This Ordinance shall take effect seven days after publication.
