
The Zoning Text Amendment Ordinance to the Jamestown Charter Township Zoning Ordinance will add Section 3.37 – Residential Fencing and Free-standing Walls to regulate fencing on residential lots.

PLEASE TAKE NOTICE that a Jamestown Charter Township Subdivision Text Amendment Ordinance, was adopted at a meeting of the Jamestown Charter Township Board held on April 20, 2020 after its first reading at a meeting of the Jamestown Charter Township Board held on March 16, 2020.

The Subdivision Text Amendment Ordinance to the Jamestown Charter Township Subdivision Ordinance will amend Section 5.3.1n2 – Location to require street trees outside of the right-of-way but within ten feet of the right-of-way.

The following Zoning Text Amendment Ordinance was adopted at a Jamestown Charter Township Board meeting on April 20, 2020.

ORDINANCE NO. 20-001

ZONING TEXT AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE JAMESTOWN CHARTER TOWNSHIP ZONING ORDINANCE TO ADD SECTION 3.37 – RESIDENTIAL FENCING AND FREE-STANDING WALLS; AND TO PROVIDE AN EFFECTIVE DATE OF THIS ORDINANCE.

THE CHARTER TOWNSHIP OF JAMESTOWN, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:

Section 1. Addition of New Section 3.37 – Residential Fencing and Free-standing Walls. A new section, Section 3.37 entitled Residential Fencing is added to the Zoning Ordinance to read in its entirety as follows.

Section 3.37 – Residential Fencing and Free-standing Walls


1. Fences and free-standing walls not exceeding three (3) feet in height, and retaining walls complying with the corner clearance and visibility requirements set forth in Section 3.14 of this ordinance, are permitted in all zoning districts.
2. Free-standing walls or fences, not exceeding six (6) feet in height, are permitted in a Side or Rear Yard in all zoning districts.
3. A fence shall not contain barbed wire.
4. The finished side of a fence or wall shall face outward, toward an adjacent property or street.
5. All fences and free-standing walls shall be maintained in a good and safe condition.

Section 2. Severable Provisions. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

Section 3. Repeal. All ordinances or parts of ordinances in conflict with this Ordinance are hereby expressly repealed.

Section 4. Effective Date. This amendment to the Jamestown Charter Township Zoning Ordinance was approved and adopted by the Township Board of Jamestown Charter Township, Ottawa County, Michigan on April 20, 2020, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended; after introduction and a first reading on March 16, 2020,

and after posting and publication following such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on May 6, 2020, which date is the eighth day after publication of a Notice of Adoption and Posting of the Zoning Text Amendment Ordinance in the *Grand Rapids Press* as required by Section 401 of Act 110, as amended. However, this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.


