ORDINANCE NO. 20-002

SUBDIVISION TEXT AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE JAMESTOWN CHARTER TOWNSHIP SUBDIVISION ORDINANCE TO AMEND SECTION 5.3.1N2 — LOCATION; AND TO PROVIDE AN EFFECTIVE DATE OF THIS ORDINANCE.

THE CHARTER TOWNSHIP OF JAMESTOWN, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:

Section 1. <u>Amendment of Section 5.3.1n2 – Location</u>. Section 5.3.1n2 of the Subdivision Ordinance is amended to read in its entirety as follows.

<u>Location.</u> On each side of the street, shade trees shall be placed outside of and within ten (10) feet of the right-of-way, in a planned pattern and consistent manner. Trees shall be placed at a distance no greater than will allow an approximately ten-foot gap between branch tips when the trees are fully grown. No tree shall be planted closer than 18 feet to any streetlight pole. Approaches to buildings should be considered when locating trees.

Section 2. <u>Severable Provisions</u>. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

Section 3. <u>Repeal</u>. All ordinances or parts of ordinances in conflict with this Ordinance are hereby expressly repealed.

Section 4. Effective Date. This amendment to the Jamestown Charter Township Subdivision Ordinance was approved and adopted by the Township Board of Jamestown Charter Township, Ottawa County, Michigan on April 20, 2020, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended; after introduction and a first reading on March 16, 2020, and after posting and publication following such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on May 6, 2020, which date is the eighth day after publication of a Notice of Adoption and Posting of the Ordinance in the *Grand Rapids Press* as required by Section 401 of Act 110, as amended. However, this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.
