Dan Larabel with Allen Edwin Homes shared proposed layout of Rolling Meadows Phase 4 connecting to Rolling Meadows Phase 3 and Bridlewood Phase 4.

**Item(s) for Information:** Jamestown Harbor Church has withdrawn their request for a portion from the Township's Park property near the Greenly and 24<sup>th</sup> Avenue.

**Public Comment for Items not on the Agenda:** Clerk DeHaan shared that the Township had applied for non-profit status with the USPS and was approved. Now outgoing ballots can now be mailed out at less than half the price of applying our own stamps and mailing.
