ORDINANCE NO. 21-003

ZONING TEXT AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE JAMESTOWN CHARTER TOWNSHIP ZONING ORDINANCE BY AMENDING SECTION 3.18 – REQUIRED RIGHT-OF-WAY OF THE ZONING ORDINANCE TEXT, AND TO PROVIDE FOR SEVERABILITY PROVISIONS, REPEAL PROVISIONS, AND AN EFFECTIVE DATE OF THIS ORDINANCE.

THE CHARTER TOWNSHIP OF JAMESTOWN, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:

Section 1. <u>Section 3.18 – Required Right-of-Way</u>. Section 3.18 of the Zoning Ordinance is to read in its entirety as follows.

Section 3.18 – Required Right-of-Way

No building permit shall be issued, and no buildings shall be erected unless the lot or parcel on which it is to be situated abuts:

- (1) A public street which has been accepted, opened and maintained by the Ottawa County Road Commission or the Michigan Department of Transportation;
 - (2) A private road approved or lawfully existing pursuant to the provisions of this Ordinance; or
- Section 2. <u>Severable Provisions</u>. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.
- Section 3. <u>Repeal</u>. All ordinances or parts of ordinances in conflict with this Ordinance are hereby expressly repealed.

Section 4. <u>Effective Date</u> . This amendment t	o the Jamestown Charter Township Zoning
Ordinance was approved and adopted by the Towns	hip Board of Jamestown Charter Township,
Ottawa County, Michigan on, 2021,	after a public hearing as required pursuant
to Michigan Act 110 of 2006, as amended; after in	troduction and a first reading on May 17,
2021, and after posting and publication following suc	ch first reading as required by Michigan Act
359 of 1947, as amended. This Ordinance shall be	effective on, 2021, which

date is the eighth day after publication of a Notice of Adoption and Posting of the Zoning Text
Amendment Ordinance in the Grand Rapids Press as required by Section 401 of Act 110, as
amended. However, this effective date shall be extended as necessary to comply with the
requirements of Section 402 of Act 110, as amended.
