

NOTICE OF POSTING OF PROPOSED ZONING TEXT AMENDMENT ORDINANCE

PLEASE TAKE NOTICE that a Jamestown Charter Township Zoning Text Amendment Ordinance had its first reading at a meeting of the Jamestown Charter Township Board held on October 18, 2021 and is scheduled for a second reading on November 15, 2021.

The Zoning Text Amendment Ordinance to the Jamestown Charter Township Zoning Ordinance will amend Section 3.29A4(a) – Private Roads to increase the minimum road width from 14 feet to 20 feet, and require valley gutter shoulders or curb when necessary, for private roads serving up to four lots.

The following Zoning Text Amendment Ordinance was introduced and a first reading completed at the Jamestown Charter Township Board meeting on October 18, 2021.

ORDINANCE NO. 21-007

ZONING TEXT AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE JAMESTOWN CHARTER TOWNSHIP ZONING ORDINANCE BY AMENDING SECTION 3.29A4(A) – PRIVATE ROADS, AND TO PROVIDE FOR SEVERABILITY PROVISIONS, REPEAL PROVISIONS, AND AN EFFECTIVE DATE OF THIS ORDINANCE.

THE CHARTER TOWNSHIP OF JAMESTOWN, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:

Section 1. Section 3.29A4(a) – Private Roads. Section 3.29A4(a) of the Zoning Ordinance to read in its entirety as follows.

Section 3.29A4(a) – Private Roads

Serving up to four (4) lots. The minimum surface shall contain twelve (12) inches of MDOT Class II sand subbase, six (6) inches of MDOT Class 22A gravel base and at least three (3) inches of asphalt placed in two (2) lifts. The asphalt mix(es) shall be approved by the Township Engineer. The minimum paved road width shall be at least twenty (20) feet and shall contain valley gutter shoulders or curb and gutter where needed for proper storm water drainage. The sand subbase and gravel base shall extend twelve (12) inches beyond the pavement edge.

Section 2. Severable Provisions. If any section, subsection, sentence, clause, phrase or portion of this Ordinance is for any reason held invalid or unconstitutional by any court of competent jurisdiction, such portion shall be deemed a separate, distinct, and independent provision and such holding shall not affect the validity of the remaining portions thereof.

Section 3. Repeal. All ordinances or parts of ordinances in conflict with this Ordinance are hereby expressly repealed.

Section 4. Effective Date. This amendment to the Jamestown Charter Township Zoning Ordinance was approved and adopted by the Township Board of Jamestown Charter Township, Ottawa County, Michigan on \_\_\_\_\_, 2021, after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended; after introduction and a first reading on October 18, 2021, and after posting and publication following such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on \_\_\_\_\_, 2021, which date is the eighth day after publication of a Notice of Adoption and Posting of the Zoning Text

Amendment Ordinance in the *Grand Rapids Press* as required by Section 401 of Act 110, as amended. However, this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.
