Moved by Miedema, seconded by DeHaan, to approve Resolution #R21-024 to approve development contract, establish street lighting special assessment district, confirm special assessment roll and matters related thereto. Carried by voice vote.

Moved by DeHaan, seconded by Miller, for second reading and final approval of Ordinance 21-006 to Amend Chapter 34 of the Zoning Ordinance regarding Spring Meadows Planned Development. Carried by voice vote.

Moved by Tacoma, seconded by DeHaan, for Final Plat Approval for Rolling Meadows Phase 5 & 6. Carried by voice vote.

It was determined that the original quote to install the pathway along Riley Street was miscalculated and didn't take the pathway all the way to 16th Avenue. Moved by Miller, seconded by McCormick, to approve that the pathway be installed the entire length of Riley between 24th Avenue and 16th Avenue. Moved by DeHaan, seconded by McCormick, to authorize and direct the Township Supervisor to sign the term sheets dated October 15, 2021 from Huntington Public Capital Corporation with respect to the proposed 2021 capital improvement bonds and fire ladder truck installment purchase agreement. Roll call vote: Yeas: McCormick, Brouwer, DeHaan, VanHaitsma, Miedema, Miller and Tacoma. Motion carried.
