Ordinance #22-005 to Amend Zoning Ordinance Section 2.3, adding Section 3.2N, amending 13.2A15, adding 13.2A16, amending 14.2J, adding 14.2K and 14.2L and amending 19.3A was introduced, read for the first time, ordered published, and tentatively scheduled for a second reading at the December 19, 2022 Board meeting.

The Board made further changes to the Peddler Ordinance and a first read is tentatively scheduled for the December 19, 2022 Board meeting.

Moved by Tacoma to approve Resolution to request Ottawa County and the Ottawa County Brownfield Redevelopment Authority to assist with a Proposed Brownfield Redevelopment Project within Jamestown Township. Motion failed for lack of support.

Mountain Bike Park update: Rock Solid plans to perform a site evaluation in December, producing a detailed listing of needed materials. They will be seeking donations based on the materials list, allowing them to start construction in the spring.

The Riley Street Bike Path was completed, earlier than expected.

The new cemetery signs were installed at the 4 cemeteries the week of November 8th.
