ZONING TEXT AMENDMENT ORDINANCE

AN ORDINANCE TO AMEND THE JAMESTOWN CHARTER TOWNSHIP ZONING ORDINANCE BY AMENDING SECTION 26.4C5 – OFF-STREET PARKING AREAS, AND TO PROVIDE FOR SEVERABILITY PROVISIONS, REPEAL PROVISIONS, AND AN EFFECTIVE DATE OF THIS ORDINANCE.

THE CHARTER TOWNSHIP OF JAMESTOWN, COUNTY OF OTTAWA, AND STATE OF MICHIGAN ORDAINS:

Section 1. <u>Section 26.4C5 – Off-Street Parking Areas</u>. Section 26.4C5 of the Zoning Ordinance is to read in its entirety as follows.

Section 26.4C – Off-Street Parking Areas

5. Raised standard or rolled concrete curb shall be used throughout the parking lot and paved areas. The Planning Commission may grant an exception on a finding that overall storm water disposition will be adequate through the construction of a 4-inch valley gutter or will be enhanced without the construction of a curb in limited locations.
