Activity

- Christian Brothers Automotive
 - o Automotive repair facility of 5,560 square feet located on the north side of Quincy Street next to Taco John's
- 2488 Riley Street
 - o Map amendment (rezoning) application to rezone approximately 36 acres from the Agricultural Rural Residential Zoning District and the Village Commercial Zoning District to the R-2 Residential Zoning District. The property is located generally at the southwest corner of Riley Street and 24th Avenue.
- Cruzan Salon
 - Home Occupation Hair Salon in an accessory building, located at 4013 8th Avenue
- Jamestown Industrial
 - o Industrial incubator (vacant industrial space) of 49,084 square feet at the south end of Central Parkway
- Qunicy Street Industrial
 - Industrial incubators (vacant industrial space) of 192,500 square feet and 48,960 square feet, located on the north side of Quincy Street, east of Royal Court.
- Luyk Outdoor Storage
 - Service Use within the Agricultural Rural Zoning District to operate an outdoor trailer and recreational vehicle storage facility, located on the north side of Adams Street, west of 8th Avenue
- Village of Jamestown Overlay
 - o Proposed text and map(s) to establish an overlay district in the Village of Jamestown pursuant to the Master Plan
- Village of Forest Grove Overlay
 - o Proposed text and map to establish an overlay district in Forest Grove pursuant to the Master Plan
