The following Zoning Map Amendment Ordinance was adopted at a Jamestown Charter Township Board meeting on July 21, 2025.

ORDINANCE NO. 25-005

AN ORDINANCE TO AMEND THE JAMESTOWN CHARTER TOWNSHIP ZONING ORDINANCE BY REZONING CERTAIN LANDS TO THE C-2 GENERAL COMMERCIAL ZONING DISTRICT, TO PROVIDE FOR REPEAL, AND TO ESTABLISH AN EFFECTIVE DATE.

THE CHARTER TOWNSHIP OF JAMESTOWN, COUNTY OF OTTAWA, AND STATE OF MICHIGAN, ORDAINS:

Section 1. Amendment. The Zoning Ordinance and Map of the Charter Township of Jamestown, Ottawa County, Michigan, the map being incorporated by reference in the Zoning Ordinance for the Charter Township of Jamestown pursuant to Chapter 5, shall be amended so the following lands shall be rezoned to the C-2 General Commercial Zoning District. The lands are in the Charter Township of Jamestown, Ottawa County, Michigan, and are described as follows:

PART NW 1/4 OF NW 1/4 COM NW COR, TH E 508 FT, S 250 FT, W 508.17 FT, N 250 FT TO BEG, EXC W 50 FT, ALSO EXC COM NW SEC COR, TH S 0D 10M 33S W 69 FT, TH S 89D 51M 36S E 50 FT TO PT OF BEG, TH S 89D 51M 36S E 150 FT, N 0D 10M 33S E 69 FT TO N SEC LI, TH N 89D 51M 36S W 150 FT TO W SEC LI, TH S 0D 10M 33S W 69 FT ALG SD LI TO BEG. SEC 9 T5N R13W. 70-18-09-100-017

Section 2. Repeal. All ordinances or parts of ordinances in conflict with this Ordinance are hereby expressly repealed.

Section 3. Effective Date. This amendment to the Jamestown Charter Township Zoning Ordinance was approved and adopted by the Township Board of Jamestown Charter Township, Ottawa County, Michigan on July 21, 2025 after a public hearing as required pursuant to Michigan Act 110 of 2006, as amended; after introduction and a first reading on June 16, 2025 and after posting and publication following such first reading as required by Michigan Act 359 of 1947, as amended. This Ordinance shall be effective on August 6, 2025, which date is the eighth day after publication of a Notice of Adoption and Posting of the Zoning Map Rezoning Amendment Ordinance in the *Grand Rapids Press*, as required by Section 401 of Act 110, as amended. However, this effective date shall be extended as necessary to comply with the requirements of Section 402 of Act 110, as amended.


